Mission

The Middlesex Coalition for Children's mission is to improve the lives of children growing up in Middletown and Middlesex County. The Coalition holds public meetings monthly on issues important to children. It convenes task forces to mobilize and coordinate community efforts to address specific children's issues, and advocates for children at the local, state and national levels.

Community Foundation of Middlesex County Fund for Greater Hartford Graustein Memorial Foundation Liberty Bank Foundation Middlesex United Way The 2013-2014 year was a year of big changes for the Coalition. In April 2013, the Coalition hired a new, part-time Executive Director to take over responsibilities for the previous volunteer Director. A steering committee was formed and with strong leadership from the board and the outgoing director, a streamlined transition occurred.

As with any transition, it takes time to fully integrate new staff into all roles, but all of the major roles and responsibilities were implemented. The new director, Izzi Greenberg, began working with the board, steering committee and sub-committees, as well as attending all relevant statewide partner organizations, committees and working groups (such as the DCF Advisory Board, the Local Juvenile Justice Collaborative, Early Childhood Alliance, etc.) as well as some new alliances with partner groups working in the Shoreline communities of Middlesex County.

The most visible work of the Director has been to design, plan and host monthly public meetings on children's issues. These have been extremely successful, attendance has increased since last year and they have grown as a strategic tool for building relationships with our legislative delegation, as well as an informed constituency. Each month, the director prepares a multi-page resource guide to inform attendees and our broader coalition about the issue of focus. These have been very widely targeted to our community and have been well received, as well as shared in other meetings and forums. Topics have ranged from the new Office of Early Childhood to Childhood Hunger to reducing School-Based Arrests, among others.

In place of the March meeting, the Coalition ran a successful Legislative Breakfast, which had record-breaking attendance, a significant portion of our legislative delegation, and offered new, coordinated materials and marketing, and an improved legislative handbook. The breakfast served to galvanize the Coalition's stance on many relevant issues that were pending in the session and continued an important dialogue with our representatives.

Additionally, the director has staffed the Board of Directors, the Board Steering/Transition Committee, the Coalition's Advocates Committee, the Childhood Hunger Task Force, and the Family Support Committee and supervises a 10-hour per week work-study student. We have added a new AmeriCorps VISTA, Sasha Rosen-Buell, whose work is shared between the North End Action Team, Opportunity Knocks and the Coalition. He will focus on Youth Organizing and Food Justice in Middletown.

A major component that the new director added to the Coalition was a social media and web presence, as well as a marketing strategy to raise the public profile of the Coalition. The Director has secured local press coverage of most events, and the Coalition has been in the newspaper monthly, on average, since October.

middlesexchildren.org facebook.com/middlesexchildren twitter.com/mxchildren This year, the Coalition took on the task of developing a social media presence. We had to develop a logo and brand identity, a website, facebook page and twitter page. Our reach was impressive for a first time venture.

Our Website (which is more of a blog format) has 41 posts which included resource guides, legislative information, our legislative handbook, a calendar and news and announcements, as well as links to our state-wide partners. It had 2587 page views since it went live in November, 2013

Our Twitter page was created in May 2013 and has 114 Followers, 127 Tweets and is following 136 other members. Our followers include a wide variety of Foundations, Advocates, Partners, Parents, Press, and Politicians

Our twitter reach is wide. Our tweets have been shared by: The Graustein Memorial Fund, Middletown Safe Schools/ Healthy Students Grant, YSB, State Rep. Matt Lesser, Community Party (a CT Racial Justice Group), CT Voices for Children, State Rep. Melissa Ziobron, CT Early Childhood Alliance, Dante Bartolomeo, The Middletown Press, Wholesome Wave, Shawn Beals, Kevin Wilhelm, and the CT Office of Early Childhood, among others. Each of these "retweets" have a very wide following, exponentially spreading our information beyond our direct followers.

Our Facebook page went live in late June, 2013. We have 159 total Likes and our highest reach is 667 in one day. The most visits in one day was 24 and the most posts on our page in one day was 9. It seems that the highest reach posts are action alerts and posts about monthly meetings.

67% of fans are women and 23.4% of fans are women 35-44 years old.

Fans are from Middletown, Hartford, Cromwell, Old Saybrook, Portland, Mansfield Center, Wallingford, Deep River, Meriden, Windsor, Ivoryton, Branford, New Haven, West Hartford, Kensington, Old Lyme, Southington, Vernon, Higganum, Middlefield, Wethersfield, Glastonbury, Hamden as well as many other states in the USA

Our Email System through Vertical Response has 1251 emails in the database, 20 different, interest-specific mailing lists, and sent 50 emails (announcements, meeting reminders, etc...) to 24,808 (non-unique) people

Our Database System through Salesforce contains 187 people (separate from our email system). While this isn't a huge number of people, it's difficult to collect information other than email, so it's a slow process. We have begun to track attendance at meetings, so we know how frequently members are attending meetings and which ones they go to.

For a first time effort, the social media reach has communicated to a wide variety of people in a wide-variety of ways from all over the state and beyond. Our goal has been to share information specific to Middletown and Middlesex County, but also state-wide action alerts, information from our partners, articles, studies and research that is relevant to anyone interested in children's justice and equality.

twitter.com/mxchildren middlesexchildren.org facebook.com/middlesexchildren Goals: Most of the goals of the Coalition are extremely long-range and it is hard to measure efficacy on a year-to year basis. The most important jobs of the Coalition are to maintain excellent relationships with child-serving programs and agencies and with our legislative delegation and to ensure that our coalition members are as informed as possible about emerging issues related to children. This has happened.

1) Goal: Identify barriers to local children's success and the most promising strategies to overcome them. Long-range Outcome: better informed, more sophisticated policy debate on children's issues.

2013-14 Outcome: this is an ongoing effort. The director worked with all committees, partners and legislators to be responsive to immediate needs, as they have come up. The director has been engaged in strategy sessions, and our coalition has made progress.

2) Goal: Raise awareness of problems and mobilize community support for solutions.

Outcome: a growing corps of people actively working to improve children's lives in Middlesex County, and more sympathizers and supporters.

2013-14 Outcome: This work has mostly happened in conjunction with #1 and at our monthly public and committee meetings, as well as through email alerts.

3) Goal: Advocate effectively for solutions with local, state and national governments.

Outcome: Governments will provide greater resources to support increasingly effective programs in Middlesex County.

2013-14 Outcome: Members advocated for increased funding for a host of programs, many of which have been expanded or implemented. The greatest successes have been in nutrition programs. Our members expanded Summer lunch and breakfast sites all across the county, and worked to add supper sites at two Middletown schools (beginning in April, 2014). In August 2014, an AmeriCorps VISTA Food Justice worker (40 hours per week) will be working with Opportunity Knocks, NEAT and the Coalition on issues around parent mobilization and childhood hunger. We have also worked to increase School Readiness, Child First and Kindergarten Kickstart, among other programs

4) Goal: Provide leadership and structure to help local agencies innovate and collaborate.

Outcomes: fewer duplicative and overlapping programs; more focus on child outcomes, less on internal agency concerns; more agency accountability.

2013-14 Outcome: this is the one area that was held back by the change in leadership. There are so many programs in the county, it has taken the full year (and may take more) for the new director to fully understand the ways in which they are interrelated and can work cooperatively. That said, the director has been involved in areas where she had existing knowledge, especially in participation with college readiness planning and Right Response/ School Safety Grant partnership with the Middletown public Schools, Juvenile Justice issues, and Childhood Hunger Issues, among others.

5) Goal: Measure success by tracking child outcomes, either directly or by publicizing Middlesex County data compiled by other organizations.

Outcomes: greater ability to distinguish between effective and ineffective strategies and programs; more responsiveness to broad economic changes (recession, export of jobs, etc).

2013-14 Outcome: Data and information has been shared both through the creation of monthly resource guides and also though social media and the website.



The Coalition co-sponsored a few great events in our community:

The Color of Justice: This forum model was created by the Connecticut Juvenile Justice Alliance. CTJJA initiated partners to run local conversations all over the state. Ours was successful in that it brought in around 200 people, and sparked a beginning conversation about racial disparity in the Juvenile Justice system. Since then, we have worked with a group of parents to start a local, parent-led *Color of Justice* working group. The group has only just begun to meet, but it seems as though it will spark some very interesting and useful conversation.

DCF Provider Fair: was held at Middlesex Community College and hosted approximately 30 different providers from all over the state. Many people who work with DCF involved children participated and attended in the fair.

Kindergarten Kickstart: will be held in the summer of 2014. This is the third year of a successful program which provides 5 weeks of "preschool" experience before kindergarten for children who has no or little to no preschool experience. The program is designed to create both the social/emotional connections and academic experience to help the children succeed in kindergarten.

Legislative Breakfast: The Coalition's Legislative Breakfast, held in March, 2014, was extremely well received. We received many compliments about organization of the event, the efficiency of Q & A with the legislators, the seemingly easy conversation, the important issues that were covered, and the attention to detail. Some changes this year include:

- Sign-in happening at the tables instead of in the hallway
- · Videography being handled by the very professional Center for New Media at Middlesex Community College
- Asking questions of the legislators in advance and learning which issues they feel most passionately about
- Making "packets" for each table that can be reused next year
- Making a hanging sign for the podium that shows up in all pictures
- Using social media to publicize the event in advance and in-person (next year we will have an event-specific #hashtag)
- Tailoring the Legislative Breakfast to be a follow-up conversation with legislators about the topics that were covered in the issue-specific monthly meetings that they participated in, propelling and deepening the conversation about the issues that we care most about in a particular year
- Allowing legislators to bring up legislation that is important to them, regardless of our Coalition's history with the bill
- Using a smaller space at the college, which makes the room seem more intimate

Coalition-led Committee Work (this does not include all committees that we participate in):

Family Support: The family support committee met every other month this year and had many interesting conversations. The one conversation that seems most relevant to members and that has received the most interest has been *housing*. Questions that have been raised are: how much subsidized housing is there in our county, how does the housing authority manage its programs, who is eligible for what, how do we navigate the shelter system, and many more. We are planning to initiate a series of workshops around housing issues for the fall, as well as strengthen our connection to the Ten Year Plan to End Homelessness and the Middlesex County Committee on Housing and Homelessness.

Childhood Hunger Task Force: The Childhood Hunger Task Force has met every other month this year and did most of its work on school meals. New meals and backpack programs were initiated in 12 communities or districts in Middlesex County (see more detail in the Childhood Nutrition Handout from the April 2014 public meeting)
